# SEISS GRANT REMINDER

The third SEISS Grant is now open for applications but claims must be made on or before 29th January 2021.

Individuals who can claim must have been eligible for the first and second SEISS grant but do not have to have claimed them.

They must also declare that they intend to carry on trading and are currently trading but are impacted by coronavirus; or were previously trading but unable to due to coronavirus.

# HMRC TIME TO PAY UPDATE

You may have heard different things about the tax return situation so we wanted to make it clear to everyone what is happening and what we can do to help you.



**BAD NEWS:** THE TAX RETURN FILING DEADLINE FOR 2019/20 RETURNS REMAINS AT 31 JANUARY 2021.



**GOOD NEWS:** IF YOU CANNOT PAY YOUR SELF-ASSESSMENT TAX BILL YOU HAVE BEEN OFFERED THE CHANCE TO DEFER YOUR 2021 PAYMENTS,

You can set up a payment plan to spread the cost of your latest Self-Assessment bill if:

- You owe £30,000 or less
- You do not have any other payment plans or debts with HMRC
- Your tax returns are up to date
- It is less than 60 days after the payment deadline

Please use the link below to log into your Government Gateway (these will be the same details that you use to login into your Personal Tax account).

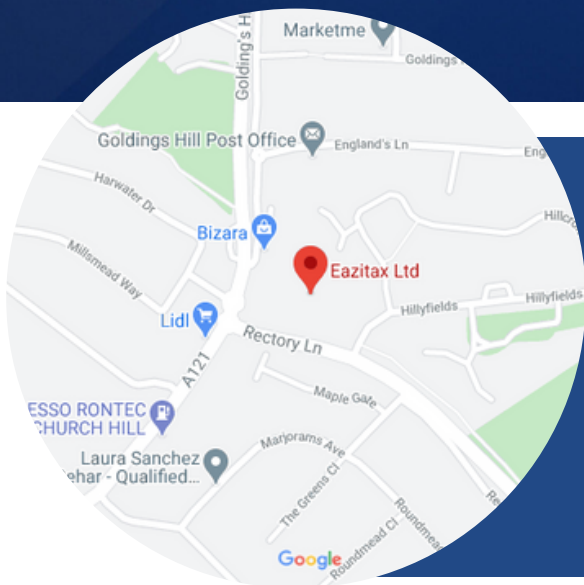
