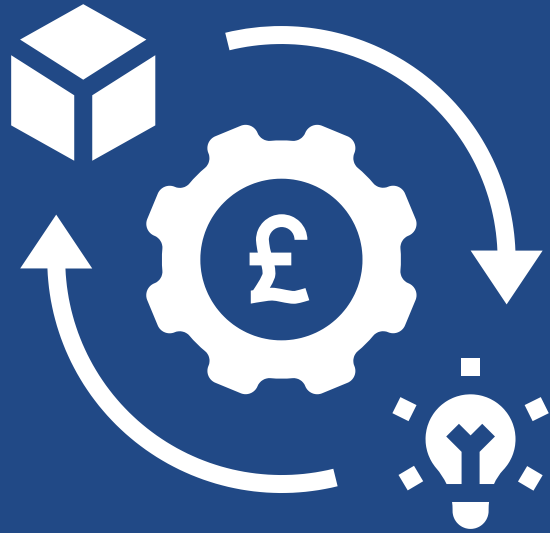

The FCA have recently been investigating Motor Finance Agreements and have found a number of issues resulting in possible compensation claims for mis-sold car finance.

The following 8 being the most common:

- Undisclosed commission
- Commission driven interest
- Inadequate explanation of contracts
- Inadequate explanation of interest
- Inadequate/Non-existent creditworthiness assessments
- Unregulated brokers
- Unreasonably high-interest rates
- Unfair fines & charges

Criteria for an eligible client:

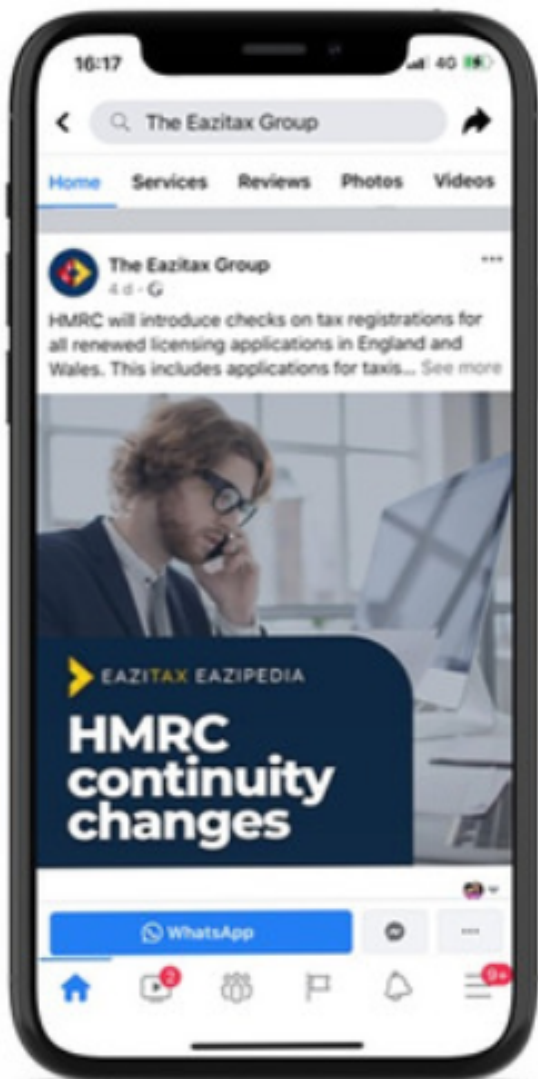
- Open or closed finance agreements.
- Agreements include; PCP (personal contract purchase), HP (higher purchase) and LTP (lease to purchase).

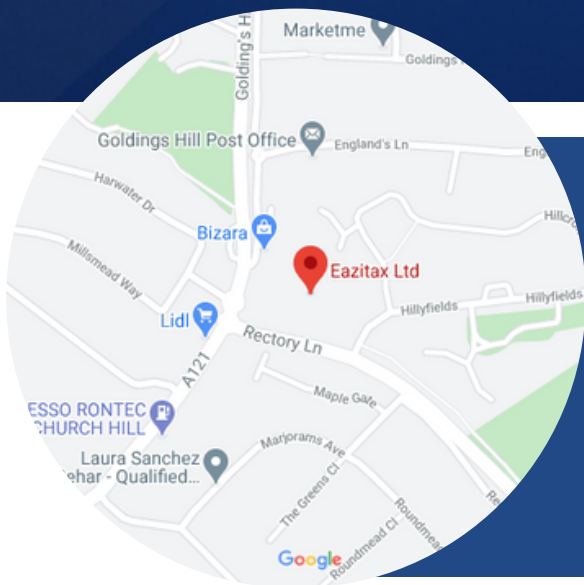
